This is a summary of the annual report for Central Maine Healthcare Corporation Medical & Dental Plan, 01-0386913/502 Health (other than dental/vision), Life insurance, Dental, Vision, Temporary disability, Long term disability and other for 01/01/2015 through 12/31/2015. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Central Maine Healthcare Corporation has committed itself to pay certain ( Health (other than dental/vision), Life insurance, Dental, Vision, Temporary disability, Long term disability and other) claims incurred under the terms of the plan.

The plan has contract(s) with HARTFORD LIFE & ACCIDENT and VISION SERVICE PLAN to pay certain ( Health (other than dental/vision), Life insurance, Dental, Vision, Temporary disability, Long term disability and other) claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2015 were \$3,172,748.

Because they are so-called experience-rated contract(s), the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2015, the premiums paid under such experience-rated contract(s) were \$695,778, and the total of all benefit claims paid under the(se) experience-rated contract(s) during the plan year was \$489,840.

The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.
